Stay safe my friends, I hope to see you at our Union meetings soon.



You can pay for doctor bills, prescriptions, dental, eye doctor bills, and even a lot of over the counter drugs that the IRS says qualifies under a medical plan. When using an HSA card for purchases it must used for the purpose of you and your families health care needs. Nobody is going to be checking on what you buy or asking to see your receipts. The only time you will need to show receipts is if the IRS does an audit on you. That is why you have to save all receipts and all transactions when you use this card. Don't be tempted to buy a bag of chips or a loaf of bread at the local CVS. The transaction will go thru ,but that's not how the HSA card was intended to be used and that

transaction is illegal under the law (IRS)( guidelines).

So please don't get your self in trouble with the law and save all your receipts in case you get a government audit. If you get caught there will be penalties fines and interest to be paid back.



Sorry to say people, I've been out on Covid-19 vacation from the end of January and to the beginning of February. I want to share this with you because it was not fun. I might be over the short term symptoms but the long term symptoms are just now rearing its ugly head. This is no joke. This is REAL. I want to remind you that management is still taking names for people that are caught not wearing their PPE in designated areas. This isn't a new rule people. It's there for YOUR protection. You do know its progressive discipline don't you? You get caught enough times you can get fired. This is not worth getting fired over. Wear your PPE. Since my Covid experience it is extremely hard for me to wear a mask, but I'd rather wear the mask then a tube down my throat. Again I ask you all to use co-worker courtesy. If you see your co-worker without their PPE give them a kind reminder. No need for confrontation. A quick reminder, then walk away. Let's look out for one another.

Remember **Think Positive** Test Negative
