SO IF YOUR ARE ASSIGNED TO WORK IN A JLG PLEASE REQUEST A RETRACTABLE LAYNARD SO YOU WILL STAY SAFELY IN THE BASKET SHOULD SOMETHING HAPPEN. 
# **LOCAL 777**



# Insurance Update

Our members are retiring at a steady pace. Medical coverage is always a concern. Medicare is an option, but there is cost associated with straight Medicare 80%/20% cost share, and a doughnut hole that you will have to pay at 100%until you hit certain dollar levels.

There are other options such as Medicare Advantage Plans and Supplemental Medical Insurance Plans. These plans will avoid getting into the doughnut hole and act more like a traditional health plan. Medicare Advantage Plans are good , and cheaper but some doctors will not accept them because they wont pay the doctors the amount of money that the doctors want to bill them for. This will limit the number of doctors you will be able to

see.

Supplemental Medical Plans are much richer plans. they usually have the most doctors in there networks and have national coverage. You will have to pay more per month to enroll in these plans ,but they offer more value for services, and have more dynamic prescription options.

In our contract there is a provision that helps us pay the monthly premiums. If you retire and you and your spouse are 65 years old with 10 years of service you and your spouse will be eligible for \$94 each per month to help you pay for some of your insurance premiums.

We at Electric Boat have our own supplemental plan called Beacon Retiree benefits group. They are a private insurance company just for our members and they offer us great value and services There # is 1-888-484-0414. Give them a call for competitive prices.



I am requesting that we follow these simple rules at the meeting: It is my understanding that the State of CT has lifted capacity requirements but I would like to follow the proposed social distancing guidelines as much as possible. - 7. Complete Sedgwick Forms and return them (Permission to obtain Medical information & Medical Work Leave Request) (absences more then 14 days)
- 8. Wear a mask, socially distance, wash your hands often, Cover your cough
- 9. If you have claim problems contact your union stewards.
