It is not that long ago that Electric Boat was driven into low rate production. President George H.W. Bush canceled the Seawolf program after one ship. Eventually after the presidential election President Bill Clinton restored two of the 29 ships that were canceled. It was almost to late.

Electric Boat had begun the shutdown mode and it was unclear if the meager contracts they had would be enough to sustain the Shipyard.

At the same time the Company was scrambling for any work they were reducing the overall footprint of the facility by tearing down many buildings, scrapping equipment, and having layoffs by the THOUSANDS.

Our Republican Congressman Rob Simmons stood idly by and did NOTHING. In fact he told representatives of the Metal Trades Council that we were not welcome in his office. Thankfully he did not last long. Simmons was challenged by Joe Courtney who narrowly won the election.

Congressman Courtney hit the ground running and was soon delivering contracts to EB. This was not only good for EB and the MTC, but for the country as a whole . 48 of the 50 states produce parts for submarines and the aging fleet needed to be replaced in defense of the nation and as a deterrent.

EB went from a build rate of half a ship a year to two ships a year earning Congressman Courtney the nickname of "Two Sub Joe". EB eventually began receiving multi year, multi ship contracts for new construction and at the same time contracts for repair work. Joe Courtney most recently delivered the largest ship building contract in history even after President Trump cut submarine construction which was overturned by Congress.

This is not all that Congressman Courtney has done. He has a 99.9% lifetime record of voting for and supporting Working Families. I am trying to change his nickname to Front Row Joe. That's where he is on OUR issues.

On Election Day, I'm sticking with Front Row Joe! Election day is November 8th. When you vote make informed decisions. MTCNLC.ORG

.INSURANCE OPEN ENROLLMENT

It's almost that time of year again. Be ready to select the coverage that is best suited for your needs.

UNION REMINDERS:

NEW HIRES YOU must stay on top of your insurance coverage. There are many choices for you to review and time limits for you to apply for these benefits. You are now eligible to join the insurance between days 0-30 of your date of hire. This is the only 30 days to execute access to the health plan. If you do nothing you will automatically get medical but will not receive dental, extra eye care, and additional life insurance. If you are married or married with children, they will not be covered. It is important to enroll as soon as possible. Do not be late. I suggest that you call to make arrangements for health insurance since all calls are recorded. In the past, there were problems with online enrollments. There are many options to choose or reject. Contact General Dynamics Service Center (1-888 432-3633) Monday – Friday 9am to 9pm. In case, there is anyone that does not know where they can check their paystub online, you need to login to your fidelity netbenefits page. On the home page, halfway down, click on the link titled "GD ESS". On the next page click "Go to GD ESS". This will bring you to the Employee Self Service homepage where you can find a link to your paystub.

INSURANCE UPDATE: If you are out for more than 30 days and need to pay insurance, the General Dynamics Service Center will mail you a form and instructions. If you do not receive this letter in a timely manner, please call (888)432-3633.

Before you retire, please contact the union, and let us know. You DO NOT need to submit a withdrawal card. Retirees can receive a union jacket and/or watch. 40 years or more will receive both. 15-40 years will receive a watch.

Make sure to inform the union if you will be out of work for an extended amount of time so that we can make sure your dues are adjusted.

If you are a Military Veteran, please see Christopher Wasilewski on first shift for support.

New Members: Between days 0-30 days after your date of hire you must log onto the General Dynamics Service Center website at www.gdbenefits.com to enroll yourself, and your dependents, in the benefits package.

As always, do not forget to use the safety boot and eyeglass program that was negotiated by the MTC. A list of the different shoe manufacturers and times that they will be outside the front gate is available. The eyeglass store is open on both the inside of the main gate and the outside entrance for your convenience, check bulletin boards for the times they are open.

IMPORTANT: If you are put on notice, going to be disciplined, or sent to Security to give a statement of any kind, you have the right to have a steward present. Your first words should be, "I want to talk to a Steward".

If you are sent to Security for any reason or are being questioned by any Management, YOU SHOULD REQUEST A STEWARD !!! REMEMBER, YOU HAVE THE RIGHT TO UNION REPRESENTATION, AND YOU DON'T HAVE TO ANSWER ANY QUESTIONS WITHOUT THIS REPRESENTATION.

IMPORTANT: Members who are out of work on any leave of absence such as Workers Compensation, Sedgwick short term disability insurance, FMLA, etc. it is your responsibility to pay your portion for medical, dental, and vision. You can be dropped from your benefits if you don't keep up your payments.

Please don't forget to notify the Union Hall (860-442-8281) if you change your address, phone number, or name. We need to have the correct information! When you notify the company of these changes they do not give the Union this new information. We appreciate your cooperation in this matter.

<u>REMINDER</u>: If you are out of work on compensation or accident & sickness insurance or any unpaid leave it is your responsibility to pay your dues. If your dues fall behind more than three months, your membership could be suspended. If you are out of work and have any questions regarding your dues, please call the Union Hall at 860-442-8281.

IMPORTANT: It is advised that you notify me one week in advance or as soon as you know when you will be returning to work from any Medical, Compensation or unpaid leave. The company doesn't know if you kept your dues paid up while you were out. It is important that I know your return date so I can submit a letter to the company to have your dues zeroed out under non collected. Once the company takes out your dues it will take me at least a month to return your money.





The Union recommends that all should enroll to assure that they have the right requests and amounts for your deductions. Please select "Enhance" if you require the seed money portion. Recent new hires must enroll again even if they just did it. In addition, I would save any confirmation of your enrollment in the chance that something went wrong.

Political Elections: I know we are all tired of hearing about the elections and can't wait until it is over, but I must mention how important these mid-term elections are especially to working families across the nation. I am pretty sure you are aware of my concerns about what the Conservative Party will do to Unions if they gain control of the Government. Insurance Update

The open enrollment period is November 16, 2022 through December 2, 2022. This is the period that you can change all facets of our benefit package, including medical insurance.

This year the company had a verification audit of our dependents. During the audit the company removed some members' spouses and children from our medical plan for not providing proof of eligibility for their dependents, even though they were eligible. Now is the time to get them back on our medical insurance during the open enrollment period.

On November 17, 2022 at the Boilermakers Union Hall, 33 Sacred Heart Drive, Groton, CT we will have a benefits briefing starting at 3:00 p.m. We will go over all aspects of the open enrollment. You may bring your spouse with you to help make the proper decisions concerning your medical and other benefits.

The company will also hold briefings in the wet dock tent.

After the enrollment period closes, the new benefits will start on January 1, 2023.

MTC Safety Report

Painters - Boilermakers - Electricians - Laborers Machinists - OPEIU - Pipefitters - Teamsters

We have had an up-tick in the to/from injuries. These are injuries attributed to walking to and from the job. We are for the year at 221 to and from injuries. That's 20% of our injuries. 116 of them are recordable, with 55 of them lost workday cases.We had a total this year so far 3288 loss work days. There is something to learn here. We need to pay better attention to our surroundings, use the hand rails, manage lines and leads, that means keep them off the ground, and don't run them in front of ladders, walkways or stairs. Don't rush and don't take shortcuts.

Also we've been having an uptick with injuries while working machinery. All I can say is, if you don't know what you're doing don't do it. Ask Ask. Grab a working leader or a senior co worker. Way too dangerous to play guessing games. Ask if the machine is in perfect running order, ask if there is something you need to know about the machine that might pop up, ask what is needed for the proper PPE to wear while operating that machine. Cold weather is creeping up on us. You get cold which causes your muscles to get cold. We have stretching machines around the shipyard. Use them. Stretch those muscles. At the beginning of the shift, after lunch before returning back to the job and one last time when the job is done and you're thinking about going home. Bring the
